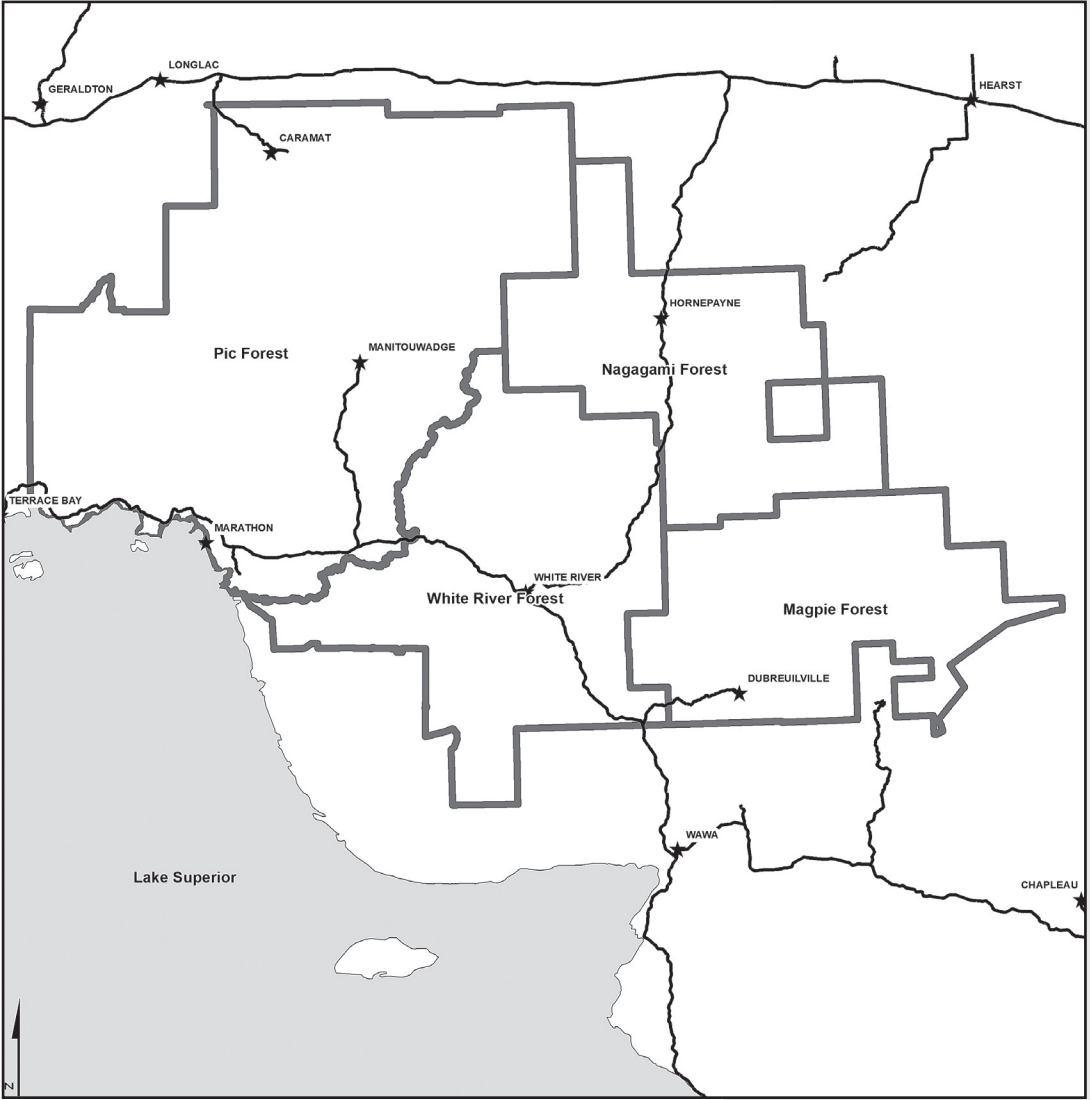

## MNRF-Approved Forest Management Plan Inspection Pic Forest 2021-2031 Forest Management Plan

The Ontario Ministry of Natural Resources and Forestry (MNRF), Nawiingnokiima Forest Management Corporation (NFMC) and the Pic Forest Public Consultation Committee (LCC) would like to advise you that the 2021-2031 Forest Management Plan (FMP) for the Pic Forest has been approved by the MNRF Regional Director and is available for inspection.



### The Planning Process

The FMP takes approximately three years to complete. During this time, five formal opportunities for public and First Nation and Métis community involvement are provided. The fourth opportunity (Stage Four) for this FMP occurred between September 15, 2020 to November 13, 2020 when the public was invited to review and comment on the draft FMP.

This 'Stage Five' notice is to advise you that the MNRF-approved FMP, including the supplementary documentation, and FMP summary are available electronically for inspection for the 10-year duration of the FMP through the office of the sustainable forest licensee and on the Natural Resources Information Portal <https://nrip.mnr.gov.on.ca/s/fmp-online>.

Interested and affected persons and organizations can arrange a remote meeting with MNRF staff with the MNRF Wawa District or Area Office to discuss the approved FMP.
